### **COVID-19 UPDATE**

Councilor Trachsel gave the update. Lincoln County will remain in the "High Risk" category. At the time of this meeting there were 70- new cases in the county for January. Phase 1A of the vaccine will start with Healthcare Providers, Care Facilities, Elderly, Care Providers and School Educators. The County received 1700 of the first round of doses and had administered 1296 vaccines with a 75% distribution in our County. (The Phases of how to administer the vaccine has changed since this meeting.)

# UPDATE SEWER PROJECT MEETING WITH GRANT WRITER RACHAEL MADDOCK-HUGHES, CITY ENGINEERS AND OTHER AGENCIES

The Mayor, City Council and the project partners had an extensive discussion on secure funds for the Wastewater Treatment project. The City brought on Rachael Maddock-Hughes to help secure grants for the project. The City and their partners are in the process of reaching out to set-up conversations with the Tribe and to bring all parties back to the table. It was decided the City would still move forward with securing funds for the project and work towards a better working relationship with the Tribe.

Had to have Ray come up to water plant on a Sunday to reprogram clear well controls knocked out in power outage

Larry from Coast range replaced #1 and #2 clear well check valves

Pump for waste water treatment plant arrived and is ready to install as soon as the influent
flows come down

### **PUBLIC COMMENT**

Ruby Moon, Community Health Director approached the Council about harm reduction, needle exchange and possibly having a sharps container located within the city to help eliminate the needles being discarded in the trash or on the ground. There was discussion and it will be discussed further with other agencies in the city about a possible location that is accessible and secure.

### **OLD BUSINESS**

The Interim Fire Chief would like the City to consider moving the Bus Stop Shelter to another location, but securing the spot it is currently located was a long process to get approved and moved. The concerns are suspicious activity, smoking and possible drug use/paraphernalia. It was agreed upon the leave the shelter where it is at its current location on Benson St. Mayor Worman will follow up with the Fire Department.

Mayor Worman read an example of the Incident Form that was created for the City to use. Councilor Trachsel had some recommendations and stated she would email T. Viar those examples and recommendations. T. Viar stated she would email the form to Councilor L. Button for her input.

Mayor Worman asked that S. Jordan have the City Council Handbooks ready for our next meeting on February 8, 2021 and we need to request that the City Attorney Doug Holbrook be present.
